The purpose of the Friends of BGO 100 Club is to raise funds for Friends of BGO in order to support BGO.

For a stake of £10 per person, per year, your name will be entered into three cash draws a year.

For each draw, there will be a 1<sup>st</sup> prize of £50, a 2<sup>nd</sup> prize of £25 and a 3<sup>rd</sup> prize of £10.

To take part, all you need to do is fill in the attached membership application form with either a standing order request or a cheque payable to Friends of British Girlguiding Overseas and return to: Francine Coles, 39 The Street, All Cannings, Devizes, Wiltshire, SN10 3PA.

#### **Rules of the 100 Club:**

1. The stake is £10 per person per year, payable by cash, cheque or Standing Order.
2. One person may hold a maximum of 5 stakes and must be over 16 years of age.
3. The year will run from 1 Dec to 30 Nov. There will be three draws per year in January, April and July.
4. For each draw there will be three prizes. The 1<sup>st</sup> prize is £50, 2<sup>nd</sup> prize £25 and 3<sup>rd</sup> prize £10<sup>1</sup>. Prizes will be paid in cash or by cheque.
5. The draw will be made at either a Friends of BGO or BGO event or in the presence of the two signatories and an independent witness.
6. Winners will be contacted after each draw.
7. Winner's names will be published on the Friends of BGO website.
8. Money which is not given in prizes or administration fee will benefit Friends of BGO.
9. The promoter of the club is Francine Coles. The authorised signatories are Christine Glover and Anne Saywell.
10. If necessary the Commissioner for BGO reserves the right to suspend the activities of the club.
11. Registered under the Gambling Act 2005 with Wiltshire Council LN/000008838.
